#### BERYLLIUM RAW MATERIALS PROCUREMENT PROCEDURE

This Procedure for Be Raw Material supplier selection (hereinafter referred to as – "Procedure") is intended for Be Raw Material supplier selection at procurement according to special procedure on the base of Paragraph 4) Clause 1 Article 73 of the Fund Procurement Procedure by the National Welfare Fund Samruk-Kazyna JSC and legal entities, fifty or more percent of voting shares (participatory interests) of which directly or indirectly belong to Samruk-Kazyna JSC on the right of ownership or trust management (Appendix No. 3 to the Protocol of the inperson meeting of the Board of Directors of Samruk-Kazyna JSC dated March 03, 2022, No. 193).

This Procedure describes and regulates the Procedure for procurement of Beryllium raw material under the special procurement procedure.

The Chairman of the Negotiation Team and the members of the Negotiation Team shall be personally responsible for the fulfilment of the tasks assigned to the Negotiation Team.

2. The following documents shall be used to apply this Procedure:

2.1 Procedure for procurement by the National Welfare Fund Samruk-Kazyna Joint Stock Company and legal entities, fifty or more percent of voting shares (participatory interests) of which directly or indirectly belong to Samruk-Kazyna JSC on the right of ownership or trust management (Appendix No. 3 to the Minutes of the in-person meeting of the Board of Directors of Samruk-Kazyna JSC dated March 3, 2022 No. 193) (hereinafter – the Procedure of the Fund).

2.2 The Regulation for PQ Conduction of Potential TO, BO Suppliers Raw materials of UMP JSC (hereinafter referred to as the PQ Regulation).

4. The special procurement procedure shall be conducted among potential suppliers who are in the pool of potential suppliers that have passed the PQ in accordance with the PQ Regulation.

5. The special procurement procedure shall involve the following sequential activities:

5.1 Issuance of Requests for Quotations for the supply of Beryllium raw material.

5.2 Review of the received price (commercial) offers for the supply of Beryllium raw material by the Negotiation Team.

5.3. Conducting negotiations.

5.4 Determination of marketing price for Beryllium raw material.

5.5. Summarising the results of negotiations.

3. The following terms with respective definitions shall be used herein:

3.1 **Negotiation Team:** a permanent Negotiation Team, which is determined by the order of the Chairman of the Executive Board of UMP JSC.

3.2 **Prequalification, PQ:** the process of evaluation of potential suppliers for compliance with the qualification requirements defined in accordance with the Regulation for PQ Conduction of Potential TO, BO Raw materials Suppliers of UMP JSC.

3.3 **Requests:** official letters in the form of Appendix 1 to this Procedure sent by an employee of the division responsible for raw material procurement to potential suppliers who have passed the PQ to submit bids for Beryllium raw material supply.

4. The special procurement procedure shall be conducted among potential suppliers who are in the pool of potential suppliers that have passed the PQ in accordance with the PQ Regulation.

5. The special procurement procedure shall involve the following sequential activities:

5.1 Issuance of requests for quotations for the supply of Beryllium raw material.

5.2 Review of the received price (commercial) offers for the supply of Beryllium raw material by the Negotiation Team.

- 5.3. Conducting negotiations.
- 5.4 Determination of marketing price for Beryllium raw material.
- 5.5. Summarizing the results of negotiations.

An employee of the department responsible for raw material procurement, if there is a need for raw material, at least once a month sends requests for quotations for Beryllium raw material supply to potential suppliers who have passed the PQ.

If there is at least one submitted price (commercial) offer, the Negotiation Team shall consider such price (commercial) offer.

When considering the submitted price (commercial) offers, the Negotiation Team shall have the right to request additional information in order to clarify the information. In order to optimize the negotiation procedure, correspondence between UMP JSC and potential suppliers by e-mail is allowed.

Potential suppliers have the right to submit additional price (commercial) offers for price reduction, which may be submitted an unlimited number of times.

The negotiation team accepts final price (commercial) offers for review.

7. Determination of the marketing price for Beryllium raw material is carried out by the Negotiation Team on the basis of the price (marketing) offers received, taking into account the result of the calculation of the production cost of finished products.

The decision to accept the cost of raw material as the marketing price for each price (commercial) offer received is made by the Negotiation Team from the economic point of view in terms of price/quality ratio, taking into account the criteria defined in the Tables 3, 4.

8. For review by the Negotiation Team of the price (commercial) offer for the supply of Beryllium raw material, the potential supplier shall submit the following documents (in Russian or English).

8.1 Potential Suppliers being residents of the Republic of Kazakhstan shall send the documents according to the Table 1:

9. Potential Suppliers shall submit their price (commercial) offers with the relevant documents attached to the e-mail address <u>tender@ulba.kz</u> within a period not exceeding

five working days from the date of the Request. Price (commercial) offers shall be protected with a password.

If potential suppliers submit price (commercial) offers after the deadline, these price (commercial) offers shall be considered by the Negotiation Team during the next meeting, which shall be organized not later than 1-2 business days from the date of receipt of such price (commercial) offers.

10. The Negotiation Team shall study the received price (commercial) offers taking into account the marketing price determined in accordance with clause 7 hereof and make a decision on the purchase of Beryllium raw material.

11. The decision to select a supplier shall be made by the Negotiation Team through open voting and shall be deemed adopted, if a majority of votes of the total number of the members of the Negotiation Team present at the meeting are cast in favour of it. In case of a tie vote, the decision voted in favour by the Chairman of the Negotiation Team or, in case of his absence, by the Deputy Chairman shall be deemed adopted.

12. In case a subsidiary of NAC Kazatomprom JSC (TH Kazakatom AG) participates in the Beryllium raw material procurement procedure, the price (commercial) offer of this company will have priority in case of equality of prices specified in the submitted price (commercial) offers and in case of equality of raw material quality.

13. The potential supplier, whose price (commercial) offer is accepted by the Negotiation Team, shall be sent a notice confirming the acceptance of the price (commercial) offer in the form of Appendix 3 hereto.

14. In case a supplier is excluded from the pool of potential suppliers due to evasion from signing the contract, as well as failure to fulfil its obligations under the contract, the renewal of such supplier's participation in the procurement of Beryllium raw material is possible, but not earlier than 12 months after the repeated passing of the PQ.

15. Procurement from the State Reserve Material is an exception to the Procedure for procurement of Beryllium raw material and is conducted not according to the rules of the procedure for procurement by the National Welfare Fund "Samruk-Kazyna" Joint Stock Company, but in accordance with the rules for the release of material assets from the State Reserve Material in the order of refreshing and dispersal.

16. The results of procurement under a special order shall be provided in the Plan of Procurement of Goods, Works, Services under a special order without the use of the web portal of procurement before the conclusion of the contract.

17. A contract with a potential supplier whose price (commercial) offer is recognized as compliant with the requirements of UMP JSC shall be concluded in accordance with the regulations of the Fund's Procedure.
